The commercial value is greater commingled than sold individually. Alone the Federal J#2 does not make enough gas to buck the line pressure. A compressor has been added to the Federal J#1A that will help both wells production. The J#2 does not produce at top allowables.

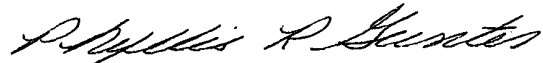

The sound mechanical integrity of the surface commingling system is dependent upon physical monitoring of the wells. Physically monitoring and verifying that both wells are producing test the surface commingled system's integrity daily.

Testing frequency of each well for accurate allocation verification would be a 72-hour well test performed annually on each well.

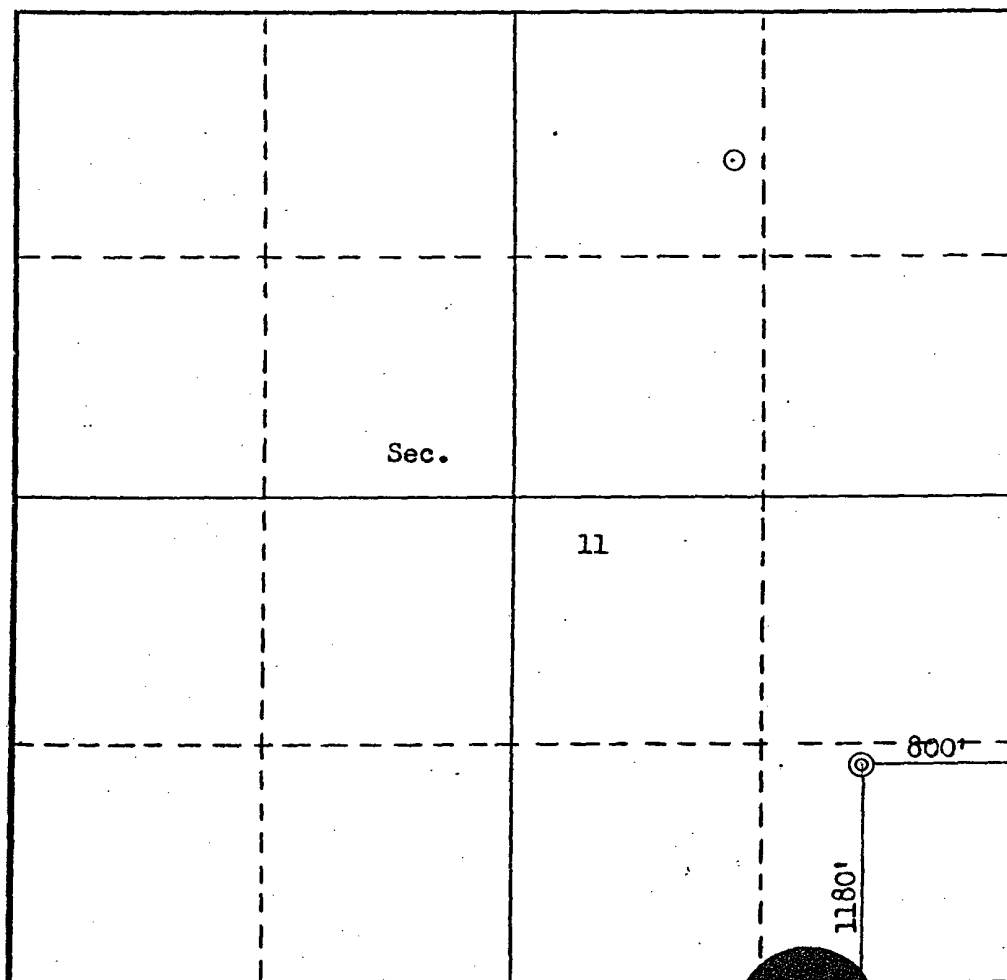

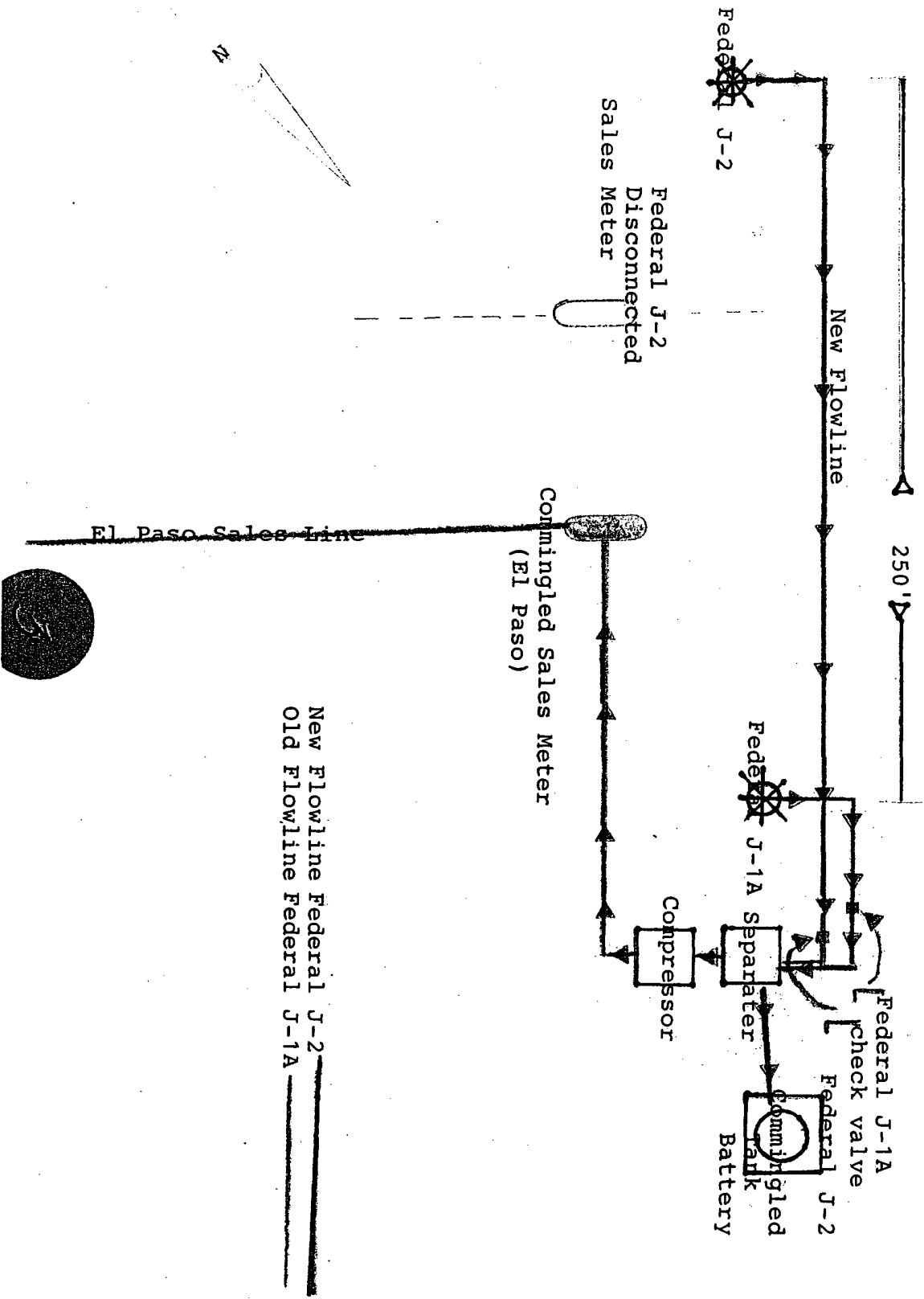

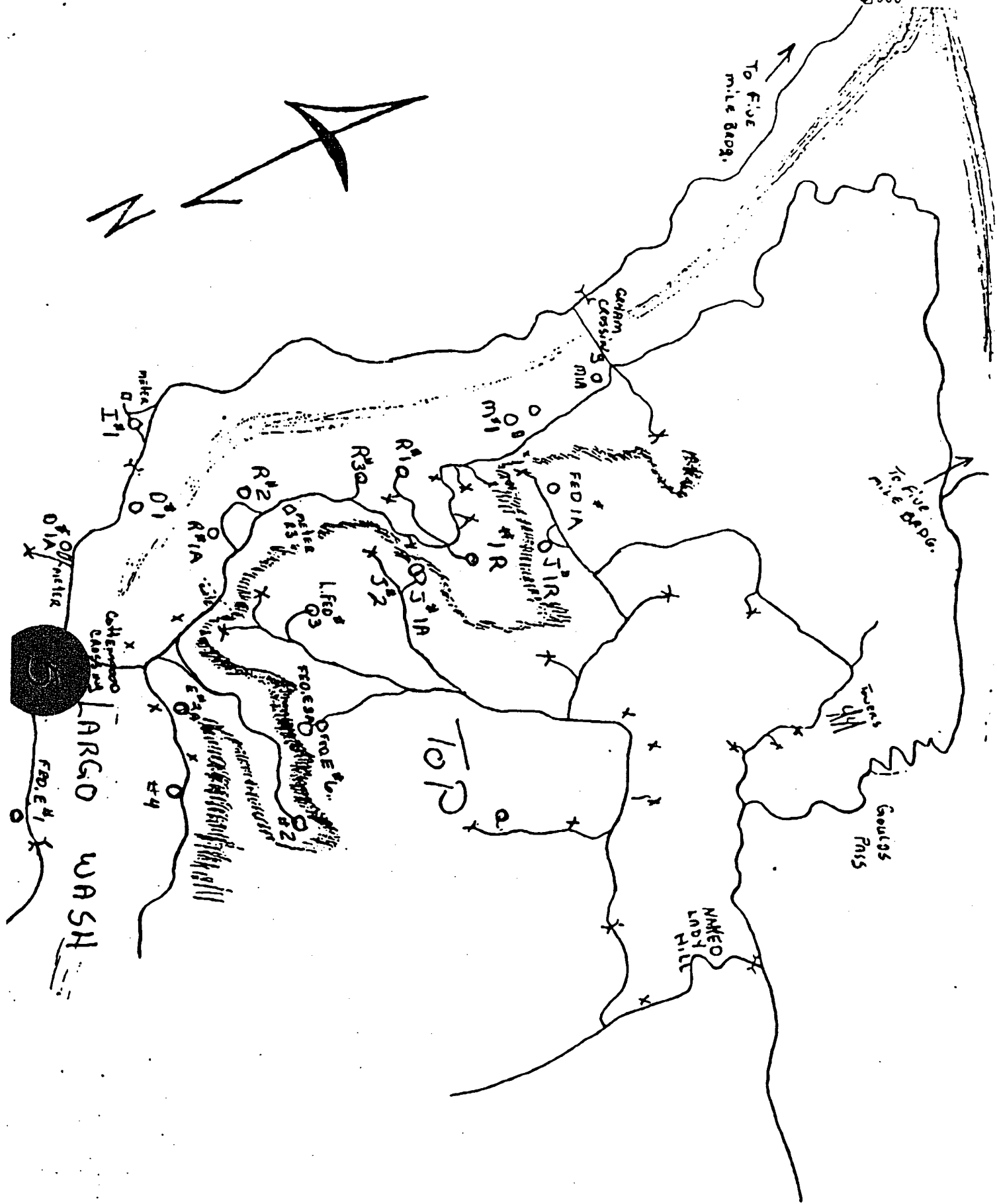
