Describe Cause of Problem and Remedial Action Taken.\* **A Fruitland Coal produced water spill of 15 BBL was discovered at the San Juan 30-6 Unit #472 on the morning of 7/18/07, due to a valve leak. The butterfly valve on the dump line going into the settling tank cracked, causing the release. All fluids were contained within the bermed area, with 10 BBL recovered by a vacuum truck.**

Describe Area Affected and Cleanup Action Taken.\* **All fluids were contained within the bermed area, with 10 BBL recovered by a vacuum truck. For remediation of the remaining impacted soils, the soil will be raked.**
