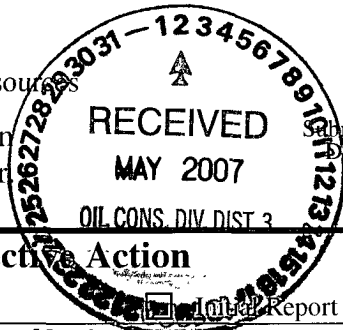

Describe Cause of Problem and Remedial Action Taken.\* **Our MSO (lease operator) discovered a 5 BBL produced water spill at the Morris A #4 on 4/30/07, due to the produced water pit tank overfilling. The tank overfilled because radar equipment for tank level telemetry was not installed properly. All fluids remained in the tank cribbing within the bermed area and 4.5 BBL were recovered by vacuum truck.**

Describe Area Affected and Cleanup Action Taken.\* **All fluids remained in the tank cribbing within the bermed area and 4.5 BBL were recovered by vacuum truck, with about ½ BBL soaking into the ground. For remediation of the remaining impacted soils, the soil will be raked and fertilizer applied. Radar equipment for tank level telemetry will be installed on the pit tank this week.**
