Natural gas calculated to be 168 MCF was burned during the fire. The local fire department and ConocoPhillips representatives responded, and isolated and extinguished the fire at 5:55 p.m. The cause of the fire was believed to be a lightening strike from a thunderstorm in the immediate area.**

Describe Area Affected and Cleanup Action Taken.\* **All gas released was burned. The gas supply was isolated and the fire was extinguished. The cause of the fire was believed to be a lightening strike from a thunderstorm in the immediate area. An internal root cause failure analysis investigation is underway.**
