If a Watercourse was Impacted, Describe Fully.*

Describe Cause of Problem and Remedial Action Taken.* **A ConocoPhillips Company MSO (lease operator) discovered a produced water / condensate spill of a maximum of 5 BBL at the Lackey A #1A on the morning of 1/21/08, due to a valve opened on the load line by a condensate thief. The vandal opened the valve, draining the water from the bottom of the tank onto the ground before stealing the condensate. Based on tank gauges, 30 BBL was missing from the tank, with approximately 5 BBL being spilled on the ground (mostly produced water) and 25 BBL condensate stolen. All spilled fluids remained within the bermed area, with 2 BBL recovered by vacuum truck.**

Describe Area Affected and Cleanup Action Taken.* **All spilled fluids remained within the bermed area, with 2 BBL recovered by vacuum truck. The affected soils were treated with fertilizer for remediation.**
