Devon would like to plug the PC in this dual PC/DK gas well as follows: MIRUSU. TOH w/tbg & pkr. Set a 4-1/2" CBP @ about 3500' (over DK perms @ 7769'-95'). With pkr set @ about 3100' on 2-3/8" tbg, establish rate & squeeze PC perms (3362'-3431') w/about 150 sx CI "B" cmt as required. Drill out through PC perms & pressure test to about 300 psi. Drill out CBP & CO to about MD7850'. Land 2-3/8" 4.7# J-55 tbg at about MD7820' & complete as a single DK gas well.
