All cement will be Class B, mixed at 15.6 ppg w/ a yield of 1.18 cu ft/sx.

1. MIRUPU. ND WH. NU BOP.
2. Confirm no leaks in BH & perfs are taking flow.
3. Mix & pump 10 sx of cement, drop 10 RCN balls & pump 79 sx of cement. WOC.
4. Perf 2 squeeze holes @ 179'. Establish rate out of BH.
5. Mix & pump 70 sx down 2 7/8" casing until good clean cement flows out the BH.
6. ND BOP. RDMOPU. Cut-off WH & anchors. Install P&A marker. Clean location.
