In reference to the BLM letter dated December 16, 2009, XTO had planned to drill this well, and therefore the pad and pit were constructed. Due to industry and economic hardships this past year, drilling of this well was put on hold. During the interim the pit was backfilled to prevent the opportunity for illegal dumping. Upon further review at the time of this letter, it has been decided that the well will not be drilled. A representative from XTO will be contacting the BLM in the near future to schedule reclamation.
