A dump valve on a 2 mm separator opened automatically and emained open when the well began to unload water. The cause for the dump to Remain open is undetermined at this time. We have not had a history of dump valves sticking open for an extended period of time.

Describe Area Affected and Cleanup Action Taken.*

Spilled water remained with the earthen berm of the overflowed tank and did not leave the lease. No remediation, and cleanup required.
