Huntington Energy, L.L.C. respectfully requests to TA the above referenced well due to uneconomic production and offset results of the CLU 477 Mancos recompleat, which was uneconomic. The TA will give necessary time to evaluate potential uphole zones. **Cancel 7/31/07 approval**
The following is the TA procedure:

- MICU. ND Wellhead. NU BOP
- POOH with 2 3/8" tubing. RIH with 4 1/2" CIBP, 2 3/8" tubing and set at 6,250'. (2/7/10: Unable to set plug. Inadvertently set plug at 5505'. rel Plug. Would not test. Will drill out plug. Reset plug at 6200'. Load hole with 2% KCL water. Test plug to 500 psi. Monitor for 30 minutes.
- COOH with tubing and lay down.
- ND BOP. NU wellhead. Retest to 500 psi. Monitor results. Release rig.
- Call BLM & NMOCD & set up Mechanical Integrity Test. Pressure test casing to 500 psi and monitor for 30 minutes. Record on a chart.
