Broke down perfs with 1050 gal 7.5% HCL acid and 63 - 7/8" bioballs. Fraced perfs 1208-1305' with 50,800# 16/30 Siberprop in 75Q N2/Lightning 15 XL foam. Set CBP at 1197'. Stage 3 - Perf San Jose 1078-1080, 1088-1092, 1096-1098, 1101-1102, 1110-1112, 1118-1122, 1135-1137, 1140-1142, 1149-1150, 1158-1160, 1164-1166, 1178-1180', 2spf, .34" diam. Broke down perfs with 1300 gal 7.5% HCL acid and 78 - 7/8" bioballs. Fraced perfs 1078-1180' with 88,500# 16/30 Siberprop in 75Q N2/Lightning 15 XL foam. Drill out CBP's at 1197' and 1315'. On 3/3/10 landed 2 3/8" 4.7#, J-55 tbg at 1373'. On 3/4/10 tested well on 1" choke for 7 hrs at 25 psi for 1020 MCFD & 1/4 BWPH. Released completion rig on 3/4/10. ✓
