Closed Loop Design Plan:

Elm Ridge Exploration Co LLC proposes to use a closed loop system to contain well bore fluid generated during the workover procedure on the above referenced well. The system will not entail a drying pad, temporary pit, below grade tank or sump. The system will consist of an above ground tank with adequate volume to hold all fluid generated during the workover operation.

1. Fencing is not required for an above ground closed-loop system.
2. Signage in compliance with 19.15.3.103 NMAC will be present
3. Water will be contained in either a water truck or a 200 bbl flat tank.

Closed-Loop Operating and Maintenance Plan:

The above referenced closed-loop system will be operated and maintained to contain liquids and solids in order to prevent contamination of any fresh water sources and to protect the environment. To ensure the operation is maintained the following steps will be followed:

1. The fluids will be vacuumed out and disposed of at the Elm Ridge Exploration water disposal facility Carson Unit WDW 242 (Permit #: SWD-933 ) Location: 719' FNL X 1802' FWL "C" – Sec.24-T25N-R12W. Solids that appear in the system will be vacuumed out and disposed of at the Envirotech Land Farm (Permit: NM-01-0011) Location: Sec.6-T29N-R12W.
2. No hazardous waste, miscellaneous solid waste or debris will be discharged into or stored in the tank. Only fluids or cuttings used or generated by operations associated with this procedure will be placed or store in the tank.
3. The division district office will be notified 48 hours of the discover of compromised intergrity of the closed-loop tank. Upon discovery of the compromised tank, repairs will begin immediately.
4. All the above operations will be inspected daily and a report will be sent via email to the main office by the supervisor on location.

Closed-Loop Closure Plan:

The closed-loop tank will be closed in accordance with 19.15.17.13 this will be done by transporting cuttings and all remaining material to the Envirotech Landfarm (Permit NM-01-0011) Location: Sec.6-T29N-R12W. All remaining liquids will be transported and disposed of at the Elm Ridge Exploration CO LLC Carson Unit WDW 242 (Permit#: SWD-933) Located: : 719' FNL X 1802' FWL "C" – Sec.24-T25N-R12W.
