In answer to your letter of January 6th to Frank Chavez, The special pool rules as amended by R-2565-D, February 10, 1986 include the interval between the base of the Mesa Verde Group and the base of the Greenhorn (Bridge Creek Limestone) member of the Mancos Formation.
