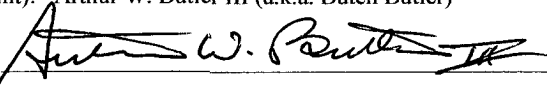

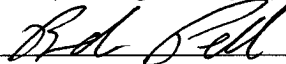

High Plains Operating Company, LLC (HPOC) is applying for this modification to its original approved Pit Permit. In the fall of 2009, we did successfully complete this well in the Morrison formation as a disposal well and began injecting in late December 2009. We have seen enough injection history to be confident that we will not need to deepen this well to the Entrada. Hence we will not need the reserve pit and are ready to close this pit. No other modifications to the original permit are being requested at this time.
