

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. It is intended to revise the approved surface cement in the subject well according to the following:

Cement with 88 sxs Type III cement with 0.25 pps Celloflake, 3% calcium chloride (113 cu. ft., 200% excess, bring cement to surface). Wait on cement appropriate time until cement achieves 250 psi compressive strength at 60 degrees F. prior to nipple up of BOPE. Wait on cement for 8 hrs for ventionally set holes before pressure testing or drilling out from under surface. Test casing to 600 psi for 30 minutes.
