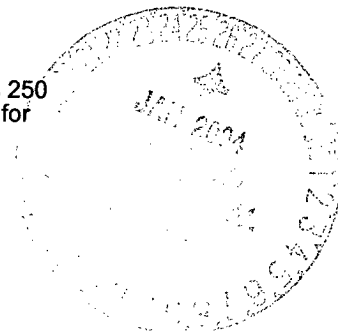

It is intended to revise the approved surface cement in the subject well according to the following:

Cement with 147 sxs Type III cement with 0.25 pps Celloflake, 3% calcium chloride (188 cu. ft., 200% excess, bring cement to surface). Wait on cement appropriate time until cement achieves 250 psi compressive strength at 60 degrees F. prior to nipple up of BOPE. Wait on cement for 8 hrs for ventionally set holes before pressure testing or drilling out from under surface. Test casing to 600 psi for 30 minutes.
