Test Ok. Released PKR & POOH. TIH & tag CMT @ 2710'. TIH w/mill & DO CIBP at 3010'. TIH & tagged 20' of fill. C/O to PBTD at 5572'. RU & flow back well thru 3/4" choke intermittently to C/O.
