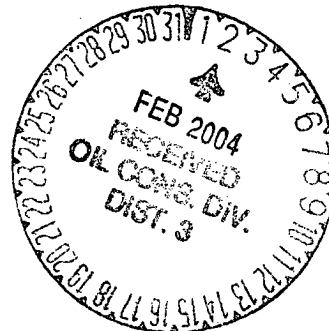

Pure Resources requests administrative approval to downhole commingle the Basin Dakota (71599) and Blanco Mesaverde (72319), which are both included in the pre-approved pools established by Division Order R-11363.

Both intervals have common ownership and produce essentially dry gas. We have not experienced any significant cross flows between these two intervals, and all the fluids are compatible. Commingling these zones will not reduce the ultimate recovery of either pool. Downhole commingling will improve recovery of liquids, eliminate redundant surface equipment, and maximize productivity.

Allocation of production will be determined later utilizing the established production rate from the Basin Dakota minus the total commingled production rate, to obtain the Blanco Mesaverde portion.
