The gauge failed and we subsequently had to run a dip-in test in order to obtain pressure data on the reservoir.

This report allows Energen to continue with POW status on the well till next reporting period end date of July, 2011.

PRESSURE AND TEMPERATURE VS DELTA TIME

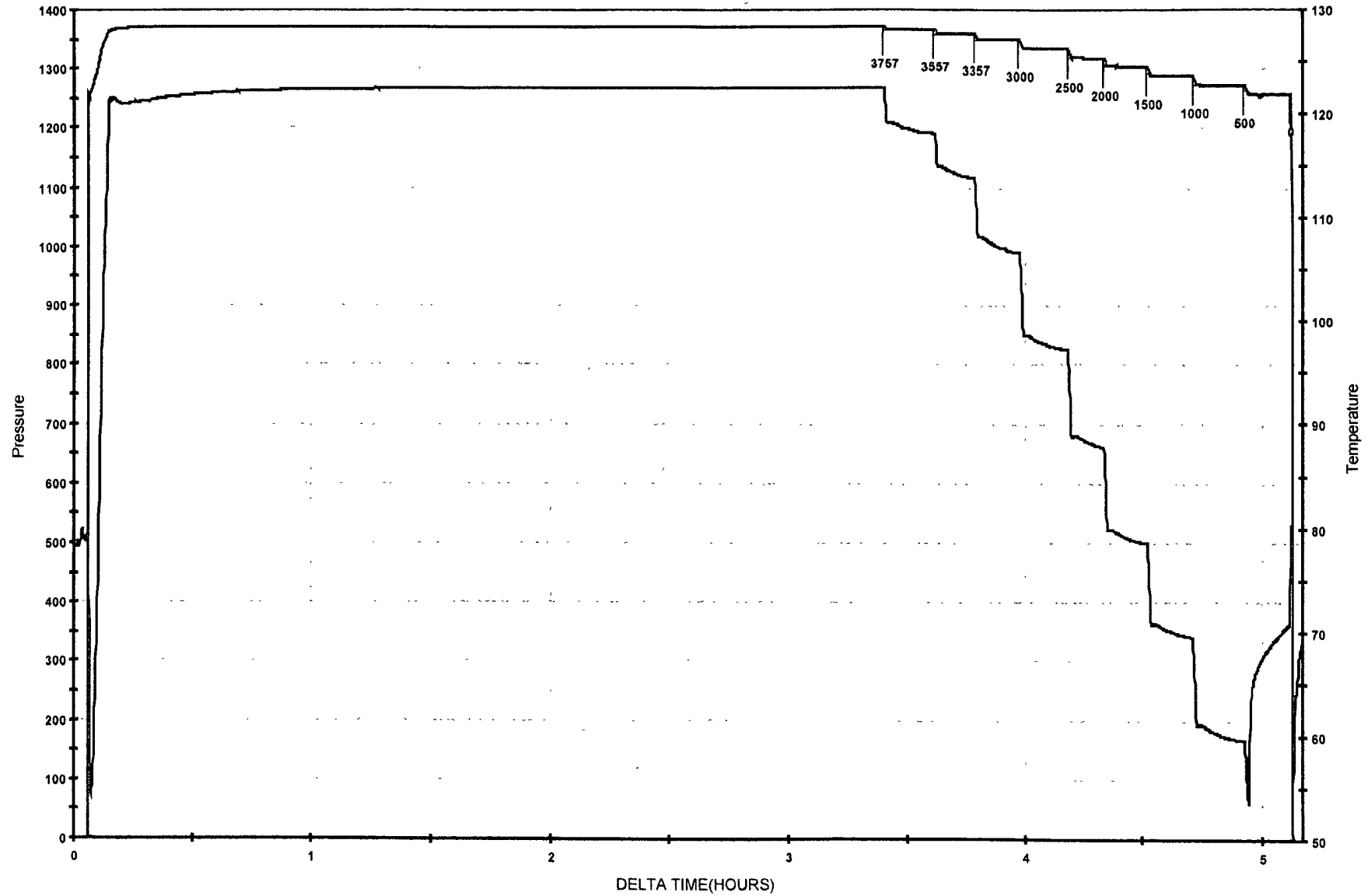
