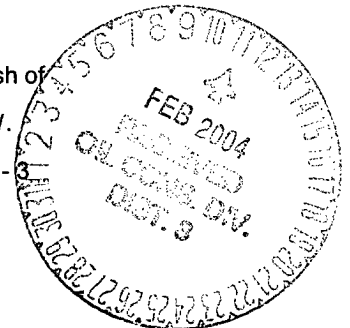

Pumped a preflush of 20 bbls water w/dye in last 10 bbls. Pumped 150 sx (174 cf - 31 bbls slurry) Class G cement w/2% BWOC CaCl<sub>2</sub>, & .25#/sx Cellophane flake. Released wiper plug and displaced plug w/15.3 bbls FW. Bumped plug @ 2322 hrs 2/2/04 w/300 psi. Circ. 29 sx (8 bbls) good cement to surface. RD & released Schlumberger. WOC. NU WH & BOP. PT BOP-OK. PT blind rams and casing to 300 psi - minutes and 1150 psi - 30 minutes. Good test.
