Pumped a preflush of 10 bbls w/dye in last 5 bbls. Pumped 150 sx (201 cf) 50/50 STD/POZ, 2% Bentonite., 5#/sx Gilsonite, 0.2% CFR-3, 3% CaCl2, 0.25#/sx Cello-flake. Dropped plug and displaced w/15 bbls water. Bumped plug to 300 psi @ 1049 hrs 2/1/04. Circ. 15 bbls cement to surface. WOC. NU WH & BOP. PT BOP, rams, and manifold to 300 psi - 10 minutes and 1000 psi - 10 minutes. PT casing to 1000 psi for 30 minutes. Good test.
