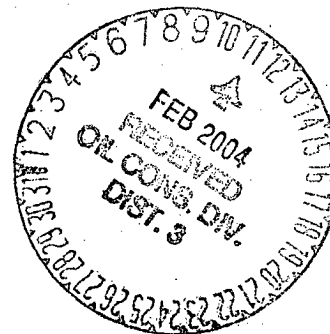

10/9/2003 TD hole at 2100'.

10/10/2003 Ran 48 jts (2084.91') of 4 1/2", 10.5#, J-55, ST&C and landed 2090' KB. Cemented 225 sx (470 cu.ft.) of CI "B" 2% econolite cement w/ 1/4#/sk celoflake and 5#/sk gilsonite, followed by 100 sx (123 cu.ft.) of CI "B" w/ 1/4#/sk celoflake and 5#/sk gilsonite. Circulated 3 bbls of good cement to surface.
