1. MIRU workover rig. ND wellhead. NU BOP and test same.
2. Test 5-1/2" casing. If casing does not hold perform bradenhead squeeze and 4", 11#, J-55 flush joint casing to 2156' and cement in place.
3. Perforate fruitland coal: 1994'-1990', 1982'-1970', 1950'-1942', 1922'-1908'

i) The NMOCD has previously approved the commingling of the two pools in NMOCD Order #11363.

ii) The pools to be commingled are the S. Blanco(Pictured Cliffs) and the Basin (Fruitland Coal)

iii) The perforations are at 2090'-2202'(Pictured Cliffs) and 1994'-1908'(Fruitland Coal)

iv) The production will be allocated using the subtractive method.

v) Commingling will not reduce the value of the total remaining production.
