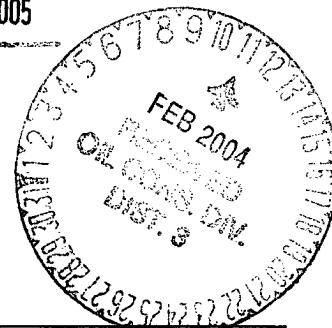

Running Horse Production Company LLC recently took over operatorship of this well and we respectfully request time to evaluate the economic alternatives for this well.
