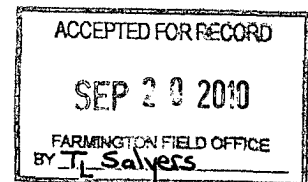

Circulate 12 bbls cement to surface. Plug down @ 8:30 am on 08/29/10. WOC. RD Halliburton. NU BOP. Test BOP to 250#, low - 15 minutes and 2000#, high - 15 minutes - ok. ✓ Test casing to 750# - 30 minutes - ok. ✓
