This equipment will consist of a 25'-30' fuel gas line, a separator and four dual unit 30KW capstone generators producing a total of 240KW. This will allow Williams to produce power that will allow us to install a water gathering system in the Rosa Unit. All equipment will be contained on the existing Rosa Unit #336 and 41C well pad (see attached drawing). We have reviewed this setting with Randy McKee of the BLM FFO.
