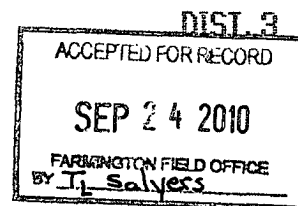

Cement with 160 sks Class G, 1/8#/sk flocele, 2% CaCl2 (175 cu.ft.). Plug down @ 10:15 am on 08/13/10. Circulate 3 bbls cement to surface. WOC. FD Halliburton. NU BOP. Test BOP to 250#, low - 15 minutes and 2000#, high - 15 minutes - ok. Pressure test casing to 750# - 30 minutes - ok. ✓
