08/09/10 Spud @ 2:00 am on 08/09/10. Drill 12.25" hole to 248'. Run 5 jts. 9.625" 32.3# H-40 ST&C casing, set @ 246'. RU Halliburton. Cement with 125 sks Class G, 2% CaCl₂, 1/4#/sk flocele (245 cu.ft.). Circulate 12 bbls cement. Plug down @ 4:00 pm on 08/09/10. WOC. RD Halliburton. NU BOP. Test BOP to 250#, low - 5 minutes and to 2000#, high - 15 minutes - ok. Casing failed to test. BLM and OOD were notified of failed casing test. Placed 4 5-gallon buckets of 20/40 sand down the 9.625" casing after failed pressure test. Inspected by Ray Espinoza of BLM. Re-test 9.625" casing to 750 psi - pressure dropped to 450 psi in 30 minutes. Test OK with BLM & OOD.
