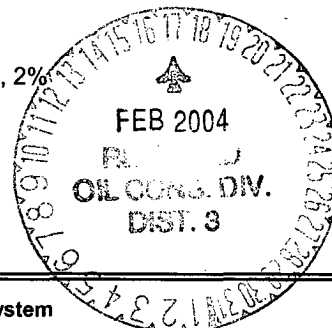

- 5) MIRU cmt equip & cmt prod csg w/50 sx Versalite cmt w/0.2% D-AIR 3000, 2% KCl & Gilsonite (mixed @ 12 ppg, yield 1.79 cuft/sx) and 20 sx Versalite cmt w/0.2% D-AIR 3000, 0.6% Halad(R)-9, 2% KCl & Gilsonite (mixed @ 13.5 ppg, yield 1.27 cuft/sx). WOC 24 hrs.
- 6) Pressure test csg to 3000 psig for 30 minutes.
- 7) Perforate Pictured Cliffs. Acidize & frac Pictured Cliffs.
- 8) TIH w/prod tbg, pump & rods.
- 9) Start well ppg.
