On 10/15/2003, BP America Production Company submitted an application for permit to drill and complete the subject well into the Basin Dakota, produce the well in order to establish a production rate, isolate the zone; then add the Blanco Mesaverde and commingle production Downhole. APD (Amended Location) Approved 01/30/2004. BP now seeks NMOCD approval to Downhole commingle production in the subject well.

The Basin Dakota (71599) & the Blanco Mesaverde (72319) Pools are Pre-Approved for Downhole Commingling per NMOCD Order R - 11363. The working and overriding royalty interest owners in the proposed commingled pools are different; therefore notification of this application is required. Letters are being mailed on 2/12/04 via certified mail, return receipt.

Production is proposed to be allocated based on a fixed percentage. We will perform a deliverability test on the Dakota, isolate the zone and complete into the Mesaverde. The deliverability test will be performed on the combined zones and DK rate will be subtracted from the total well stream to establish the MV rate.

Commingling Production Downhole in the subject well from the proposed pools with not reduce the value of the total remaining production.


