The closed-loop tank was closed in accordance with 19.15.17.13. This was be done by transporting cuttings and all remaining sledges to TNT Environmental Inc. (Permit #NM-0008-001) immediately following rig operations. All remaining liquids will be transported and disposed of in the company disposal well: Simms Federal SWD #1 (order SWD-665). The tank was removed from the location as part of the workover rig move. The tank was completely on location during workover operations. At time of will abandonment, the site will be reclaimed and re-vegetated to pre-existing conditions when possible.
