This well was first delivered on 11/17/2010 and produced natural gas and entrained hydrocarbons.

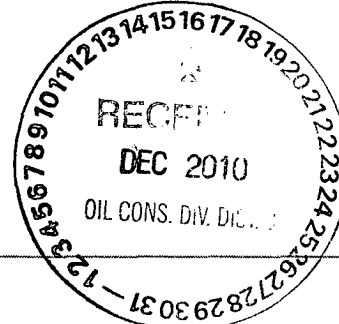
