Our repair of this well was delayed due to a bad walking beam saddle bearing. The bearing has been rebuilt and has now been re-installed. We are currently rigged up on this well, and are waiting on a hot oil truck, before pulling the rods and tubing. The hot oil truck will not be available until Monday, December 6, 2010. After that, it should take several more days to complete our repair operations. We expect to have this well producing again by December 15, 2010.
