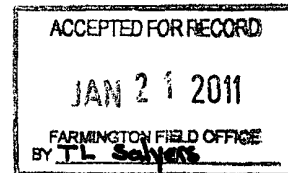

10-28-10 - Pressure test 4-1/2" casing to 1600 psi for 30 minutes, good test ✓
