
13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomplete horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompletion in a new interval, a Form 3160-4 must be filed once testing has been completed. Final Abandonment Notices must be filed only after all requirements, including reclamation, have been completed and the operator has determined that the site is ready for final inspection.)

In response to a BLM letter dated January 13, 2011 from Stephen Mason, HEP Oil GP, LLC plans to set a compressor on approximately February 4, 2011 to reestablish hydrocarbons in paying quantities within 45 days of installation.

If the compressor fails to reestablish production, HEP plans to submit a sundry notice to recomplete to the Mesa Verde/Point Lookout this summer when weather conditions allow for a service rig. If this proposed recompletion fails to produce in paying quantities than HEP will submit a procedure to plug and abandon the well.
