10/14/2010 the location was inspected by both BLM & BP personnel and all agreed the surface is restored.

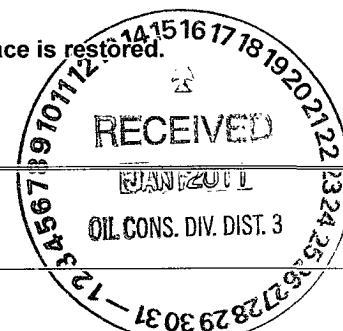
