1/26/11 RU Halliburton equip. Pmp 17 bbls of Xylene, switch to 15% HCL, pmp 48 bbls acid, flush w/10 bbls produced water. Pumped @ 2.0 bbls/min @ 2400psi, wait 30 min, pmp 25 bbls of produced water @ .7 bbls/min @ 2200 psi. Wait on frac to Work. Displace acid out the end of tbg & into formation @ 3 bpm/2720 psi w/80 bbls of produced water.

1/27/11 RU slickline unit RIH & set test plug in F-nipple @ 8471' PT tbg & pkr to 3011# & after 15 mins, lost 11# and csg pres stayed steady. RIH w/slk line retrieve plug. RD Halliburton equip.


