It is intended to repair a casing leak in this well as follows:

1. MIRU. TOH w/rods and tubing.
2. TIH and sent RBP @ 5900'. Isolate leak with packer. Squeeze cement w/sufficient amount of cement to isolate leak. WOC.
3. TIH with bit and drill out squeeze. Test casing to 500 psi. TOH.
4. TIH and retrieve RBP. TOH.
5. Rerun tubing and rods. Return to pumping and production.
