In accordance with Case 14539, Order #R-13347, it is intended to downhole commingle the Blanco MV (72319) the Basin DK (71599) and South Blanco PC (72439). The existing MV perforations are 4842'-4976', 5410'-5552', existing DK perforations are 7409'-7624', 7682'-7690 and the estimated PC perforations are 3197'-3264'. Selectively perforate and fracture zone. Clean out to PBD. Run tubing & put well on production. Recommended allocation will be by the Subtraction method following 60 days of stabilized production. Commingling will not reduce the total remaining production's value. The interest owners are identical for each zone. Rates reported to MNOC - Aztec for final determination.

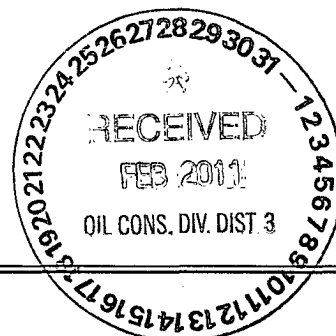
