Both pools are in the NMOCD pre-approved pool combinations (per Order R-11363) for DHC in the San Juan Basin. Please see the attached spreadsheet for justification of proposed allocations.

Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights. The NMOCD was notified of our intent to DHC via Form C-103 on 2/23/2011.
