Started R/R & surging well with air, mist and foamer. Cleaned out for approx. 15 days. COOH. RIH w/5-1/2", 15.5# J-55 casing for liner. Set liner @ 3365' w/top of hanger set @ 3056'. Overlap into the 7" casing - 38'. COOH. RU Blue Jet & perforated liner @ 4 spf .75" holes - 3148'-52'; 3238'-40'; 3242'-46'; 3258'-60'; 3273'-83'; 3308'-18'; 3346'-56' = 168 holes. RD Blue Jet. RIH w/2-3/8", 4.7# tubing and set @ 3341' w/"F" nipple set @ 3309'. ND BOP & NU WH. Pumped off expendable check. RD & released rig 11/24/02. Turned well over to production to first deliver.
