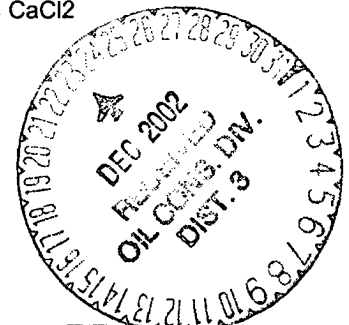

Cemented casing w/120 sx Class "B" cement w/3% CaCl<sub>2</sub> & 1/4#/sx celloflake (mixed @ 15.6 ppg, 1.18 cuft/sx). Circulated 15 bbls cement to surface. PT BOP's & surface casing to 1,000 psig for 30 minutes. Held OK.
