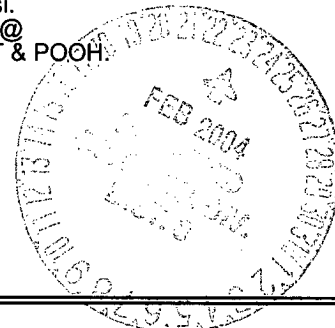

TIH & shot SQZ hole @ 320' w/2 SPF. Mix & pump 70 SXS CLS G NEAT CMT. SQZ to 1000#. TIH & tag CMT @ 315'. DO CMT & POOH. Press test SQZ to 500 psi. OK. TIH & latch onto RBP. TOH. TIH & C/O to PBTD. Let well flow natural for 2 hrs. TIH & C/O to PBTD. TIH w/2-3/8" production TBG & land @ 7187'. ND BOPs. NUWH.
01/22/2004 RDMO workover rig. Well returned to production.
