On November 25, 2003, XTO Energy Inc. set a 4-1/2" CIBP @ 2300' to temporarily abandon the Pictured Cliffs. At this time XTO Energy perforated & stimulated the Basin Fruitland Coal from 2218' - 2282'. The Basin Fruitland Coal will be produced & evaluated until sufficient data has been gathered to determine a downhole commingle allocation.
