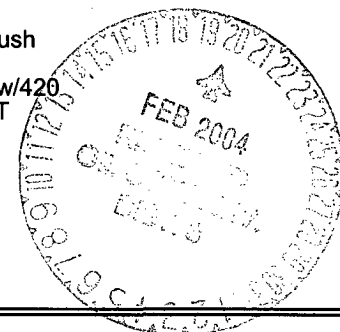

Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped 150 sx (1174 cf - 31 bbl slurry) Class G cement w/2% CaCl₂, .25#/sx Cellophane. Released wiper plug and displaced plug w/15 bbls FW. Bumped plug w/420 psi @ 0530 hrs 2/15/04. Circ. 15 bbls good cement to surface. WOC. NU WH & BOP. PT-OK. PT casing to 300 psi - 3 minutes and 1000 psi for 30 minutes. Good test.
