XTO Energy Inc. proposes to recompletable this well to the Pictured Cliffs formation per the following procedure:

The Pictured Cliffs formation will be perforated from 2,780' - 2,832' (select fire, 0.34" EHD, 20 holes), acidized with 1,000 gallons of 15% HCl acid, and stimulated down 7" casing with 75Q, N2 foamed linear gel carrying 115,000# of 16/30 sand. The Mesaverde, Chacra, and Pictured Cliffs formations will then be downhole commingled and returned to production.
