Closed Loop System (No drying pads & off-site disposal)

General Plan-Well Abandonment

Design Plan - 19.15.17.11(H) NMAC:

In accordance with Rule 19.15.17.11 New Mexico Administrative Code (NMAC), HEP Oil GP, LLC proposed closed-loop system will not incorporate drying pads, temporary pits, below-grade tanks or a sump area. The main component of this system will consist of above-ground welded steel tanks or 'pits' suitable for holding well fluids, used for circulating and cementing operations, and the debris that is removed from the hole. The volume of the tank(s) will be sufficient as to allow gravity segregation of the debris from the fluids, yet still comply with free board requirements.

1. Fencing is not required for the above-ground closed-loop system
2. It will be signed in accordance with Rule 19.15.3.103 NMAC

Operations and Maintenance Plan - 19.15.17.12(A) NMAC:

The closed-loop drilling systems will be operated and maintained to contain liquids and solids to prevent contamination of fresh water and protect public health and the environment. The following procedure will be followed:

1. The liquids and solids will be vacuumed from the steel 'pits' on an intermittent basis, so as to provide adequate free board and enough time for gravity segregation to occur. The well debris will be hauled to a permitted solid waste disposal site, either EnviroTech (Permit #NM01-0011) or Industrial Ecosystems Inc (Permit #NM01-0010B).
2. No hazardous wastes will be discharged into or stored in the steel 'pits' of the closed-loop system. Only fluids and debris used or generated during the well operations will be placed or stored in the tank.
3. In the event the closed-loop system develops a leak, HEP Oil GP, LLC personnel or their agent, will remove all liquids above the leak line immediately and notify the NM OCD Aztec District office with 48-Hours of the discovery. Repairs to the system will begin immediately.

Closure Plan - 19.15.17.13(D) NMAC:

This general plan as submitted by HEP Oil GP, LLC does not consider the use of drying pads and on-site burial of the well debris.

The steel 'pits' will be emptied of fluids and debris and disposed of at permitted division facilities. The fluids in the steel 'pits' will be disposed of at the Basin Disposal's SWD facility (Permit #NM-01-005).

Solids or other well debris will be vacuumed from the steel 'pits' and hauled to a solid waste disposal site, either EnviroTech (Permit #NM01-0011) or Industrial Ecosystems Inc (Permit #NM01-0010B).

Upon their emptying, the steel 'pits' will be hauled off of the well location back to the yard of the rental company from which these items were rented. At the time of well abandonment, the well site will be reclaimed, re-contoured and re-vegetated to as near original conditions as possible.
