Potential well construction subsurface problems. The exact problem is under investigation. A natural seep has not been ruled out. Water quality analysis of water is attached and shows trace amounts of hydrocarbons (TPH= 0.7 mg/l GRO and total BTEX 657 ug/l)

Describe Area Affected and Cleanup Action Taken.*

Small water seep flowing out of hillslope approximately 25 feet down the eastern slope of the location. The minor surface water flow travels down a natural contour away from location approximately 200 yds and dries up..
