4/22-27 Flow back frac.

4/28-29 TIH and clean out well to CBP at 4053'.

4/30/11 Drilled out CBP at 4053'. Circulate hole clean. TIH to PBTD & tagged at 6410'.

TOOH. TIH with 2.375" 4.7#, J-55 tubing.

5/2/11 Set 2.375" tubing @ 6060'. SN at 6072'. ND. BOP. NUWH. Shut in well.
