It is intended to remove the packer in the subject well and commingle the formations Blanco Mesaverde (pool 72319) and the Gobernador Pictured Cliffs (pool 77440) production according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The State of New Mexico has been notified in writing of this application.
